- 1.) **Privilege Speech of Senator Teofisto "TG" Guingona III on The Recent Incident in Mindanao Involving "Lumads"**
- 2.) **PSRN 1572:** Resolution Urging the Appropriate Committee/s to Conduct An Inquiry, In Aid of Legislation, Into the Veracity of the Reported Harrasment, Killings, Forced Evacuations and Dispossession of Ancestral Lands, Among Others, In the Communities and Tribal Schools in the Lumad Areas in Mindanao, With the End Goals of Immediately Putting An End to It, Meting Out the Appropriate Sanctions to Those Liable and Formulating Legislative Measures Protecting, Furthering and Improving the Welfare and Well-Being of Various Indigenous Peoples and Tribes in the Philippines. - 6.) **PSRN 1588:** Resolution Directing the Proper Senate Committee To Conduct An Inquiry, In Aid of Legislation, On the Report That 800 Lumad School Children Are Among Evacuees in Surigao Del Sur Due to the Operation of Paramilitary Groups. (Sen. Santiago)
