1. **Senate Resolution No. 699** entitled: "A Resolution Directing the Appropriate Senate Committee to Conduct an Inquiry on the Philippine Downstream Natural Gas Industry Policy with the End in View of Enacting Appropriate Legislation for its Development and Regulation in Light of the Malampaya Franchise Expiration in 2024;"
2. **Senate Bill No. 765** entitled: "An Act Ordaining the Development of the Downstream Natural Gas Industry, Consolidating for the Purpose all Laws Relating to the Transmission, Distribution and Supply of Natural Gas and for other Purposes;" and
3. **Senate Bill No. 1371** entitled: "An Act to Strengthen the Jurisdiction and Power of the Department of Energy over Petroleum Pipeline Operations and for this Purpose Provide a Petroleum Pipeline Code to Prescribe Standards for the Design, Construction, Operation and Maintenance and Abandonment of Liquid Petroleum Pipelines and Appropriating Funds therefor, and for other Purposes."
