The Committee on Local Government joint with the Committees on Banks, Financial Institutions and Currencies, and Ways and Means, will conduct a **Technical Working Group** (TWG) meeting on **Monday, July 16, 2018, 1:00 PM at the Senator Claro M. Recto Room**, 2nd floor, Senate of the Philippines, to discuss the following bills:

SBN 110 (Sen Pimentel) - AN ACT PROVIDING FOR THE SHARE IN THE NATIONAL TAXES OF LOCAL GOVERNMENT UNITS, AMENDING FOR THIS PURPOSE REPUBLIC ACT NO. 7160, OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991

SBN 1788 (Sen Angara) - AN ACT TO ENHANCE THE SHARE OF LOCAL GOVERNMENT UNITS IN INTERNAL REVENUE TAXES

SBN 843 (Sen Recto) – AN ACT STRENGTHENING LOCAL GOVERNMENT UNITS BY INCREASING TO FIFTY PERCENT (50%) THE ANNUAL INTERNAL REVENUE ALLOTMENT SHARE OF LOCAL GOVERNMENT UNITS AND FOR OTHER PURPOSES

SBN 822 (Sen Recto) – AN ACT TO INCLUDE IN THE COMPUTATION OF THE INTERNAL REVENUE ALLOTMENT (IRA), ALL THE NATIONAL INTERNAL REVENUE TAXES COLLECTED BY THE BUREAU OF INTERNAL REVENUE AND THE BUREAU OF CUSTOMS, AMENDING FOR THIS PURPOSE SECTION 284 OF REPUBLIC ACT NO. 7160, OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991

SBN 810 (Sen Recto) – AN ACT STRENGTHENING LOCAL GOVERNMENT PARTICIPATION IN NATIONAL DEVELOPMENT IN INCREASING THE SHARE OF LOCAL GOVERNMENT UNITS IN THE NATIONAL INTERNAL REVENUE TAXES, AMENDING FOR THE PURPOSE SECTION 284 OF REPUBLIC ACT NO. 7160, OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991
