Please be informed that the Committee on Agriculture and Food joint with the Committee on Agrarian Reform will conduct a **public hearing** on **19 May 2017 (Friday), 11:00 a.m.** at the **Sen. Recto Room**, Senate of the Philippines, GSIS Complex, Pasay City, on the following legislative proposals, to wit:

- **SBN 236** – AN ACT TO INCREASE TO FIVE MILLION PESOS THE APPROVING AUTHORITY OF THE COMMISSION ON AUDIT TO RESTRUCTURE OR CONDONE THE UNPAID INTERESTS, PENALTIES AND/OR SURCHARGES ON AGRICULTURAL LOANS OF FARMERS AND FISHERFOLKS, *introduced by Sen. Honasan II;*

- **SBN 262** – AN ACT CONDONING UNPAID AMORTIZATIONS OF LANDS AWARDED TO COMPREHENSIVE AGRARIAN REFORM BENEFICIARIES AND FOR OTHER PURPOSES, *introduced by Sen. Recto*; and
- **SBN 605** – AN ACT PROVIDING FOR THE CONDONATION OF UNPAID INTERESTS, PENALTIES AND SURCHARGES ON LOANS SECURED BY FARMERS, FISHERFOLKS AND AGRARIAN REFORM BENEFICIARIES FROM THE DEPARTMENT OF AGRARIAN REFORM (DAR), THE DEPARTMENT OF AGRICULTURE (DA), THE PEOPLE'S CREDIT AND FINANCE CORPORATION (PCFC), THE COOPERATIVE DEVELOPMENT AUTHORITY (CDA), THE NATIONAL FOOD AUTHORITY (NFA) AND THE QUEDAN AND RURAL CREDIT GUARANTEE CORPORATION (QUEDANCOR), *introduced by Sen. Trillanes IV*.
