1.

SBN 590 – AN ACT AUTHORIZING THE COURT TO REQUIRE COMMUNITY SERVICE IN LIEU OF IMPRISONMENT FOR THE PENALTY OF *ARRESTO MENOR*, AMENDING FOR THE PURPOSE CHAPTER FIVE, TITLE THREE, BOOK ONE OF ACT NO. 3815, AS AMENDED, OTHERWISE KNOWN AS "THE REVISED PENAL CODE" (*Introduced by Senator Antonio "Sonny" F. Trillanes*);

Primicias-Agabas and Gloria Macapagal-Arroyo*).

HBN. 1344 – AN ACT PRESCRIBING STIFFER PENALTIES FOR THE CRIME OF DELIVERING PRISONERS FROM JAIL AND INFIDELITY IN THE CUSTODY OF PRISONERS, AMENDING FOR THE PURPOSE ARTICLES 156, 223 AND 224 OF ACT NO. 3815, AS AMENDED, OTHERWISE KNOWN AS THE REVISED PENAL CODE OF THE PHILIPPINES (*by Representatives Romeo M. Acop, Marlyn L. Primicias-Agabas*).
