SENATE'S BEST¹ by Senate President

ood afternoon to my fellow Senators, other civil servants, distinguished guests, friends, my fellow Filipinos.

Today we close the 2^{nd} Regular Session of the Eighteenth Congress which convened in July last year.

Naalala ko, Hulyo noong nagdaang taon, nagtipontipon ang inyong mga Senador sa pagbubukas ng sesyon sa kasagsagan ng pandemya.

Matindi ang mga agam-agam sa mga panahong iyon; ngunit nanatili ang pag-asang magiging maayos din ang lahat. Hindi nawalan ng loob ang inyong Senado. Bagkus, mabilis itong umaksiyon. Kaya noong September 2020, agad na naipasa ang batas na nagpapalawig ng naunang Bayanihan, na tinawag nating Bayanihan to Recover as One Act, na nakatuon hindi lamang sa kalusugan ng bawat Pilipino ngunit pati na rin sa muling pagbangon ng ekonomiya.

Lumipas ang mga araw, at sa pagdating ng mga unang buwan ng 2021, nakahinga tayo nang maluwag. Sa mga araw na iyon, natukoy natin ang mga pangunahing hakbang para maging ligtas ang ating mga komunidad. Nagbigay ng mga ayuda ang mga sangay ng ating pamahalaan sa ating mga kababayan. Unti-unting nagluwag

ang panuntunan ng kuwarentenas. Umasa tayong lahat nakahit na papaano-makababalik na sa trabaho ang marami sa atin. Na napanghawakan na natin ang pandemya.

But when we thought we had a handle on the situation, when for a moment we saw the beginnings of a silver lining, a spike of infections hit Metro Manila. The numbers rose as infections spread. Our health system become overburdened again. It seemed as if we were again knocked down on our knees.

The experts have predicted that this would happen. A pandemic's cycle may involve waves of resurgence as communities wade into the ebb and flow quarantine restrictions. And while the experts search for further solutions, your Senate's desire to work together with the House of Representatives as well with the Executive branch to contain yet again the virus, did not falter.

Kaya naman maliban sa Bayanihan Laws, isinabatas na ng Senado noong Pebrero 2021 ang pagpopondo, agarang pagbili, at ang paglalahad ng pamamaraan at proseso ng pagbabakuna.² Isa itong kritikal na hakbang para mapangalagaan ang immunity ng lahat, at sa huli ay manumbalik sa normal and lahat.

In this regard, same people say that—as a prediction based on science—the ensuing spike could not have been avoided. On the other hand, some people think that the government should have done more.

I know that in difficult times, the blame game is easy to play. But I also know it does not do the situation any good. *Madali ang humanap ng sisi. Ngunit, sa ganang akin, hindi ito nakabubuti.* Nonetheless, I also believe that in moments of national crisis, our people expect more from their government. And, therefore, it becomes the duty of us in the Senate to fulfill this expectation to the highest degree possible.

Mga kababayan ko, alam nating patuloy na binabago ng pandemya ang takbo ng ating buhay.

Sabi ng mga siyentipiko, mananatili ang buhay kuwarentenas habang hindi napipigil ang paglaganap ng virus.

Alam nating nakasalalay—hindi lamang sa isang sector kundi sa bawat isa sa atin—ang masinop, at maagang pagbangon ng ating bayan. Higit kailanman, nasa harap natin ang pagsubok sa ating tatag at pagkakaisa.

Dahil sa panahon ng krisis, alam nating marami ang umaasa sa pamahalaan. Nakikiisa ang Senado sa mga nakadadanas ng hirap. Hindi natin sila pababayaan.

To ensure that all public services be maintained, your Senate approved the extension of the availability of the 2020 appropriations to December 2021, and of the Bayanihan to Recover as One Act funds up to June 30, 2021.³

Aware of the urgent needs of the pandemic, your Senate committed to a legislative policy of shepherding government programs and resources for fighting COVID-19. Early this year, Republic Act No. 11523, otherwise known as the Financial Strategic Transfer (FIST) Act, was passed into law to ensure financial resiliency against the pandemic.

Simultaneously while addressing the medical aspect of the pandemic, we have—since day one—been in discussion with key

people in an effort to address the labor and financial; the cultural and psychological repercussions of a society that requires social distancing.

Some say that we only need to ride out the worst part of the pandemic; that, for now, no one is expected to demand more.

I say that more is required from the government, not only because it has the resources to do so but because the best public service is government's covenant to its people.

As Senate President, and in behalf of my colleagues, I am here to commit to that promise. Our people have given us their trust. And by the grace of God, we will not fail them.

The Senate, through its hearings, and informal consultations, is in touch with the medical experts with the end in view of crafting laws to stay steps ahead of the natural course of the pandemic.

We have, in various legislative stages, twenty-one (21) bills of local application creating schools, hospitals, and expanding bed capacity in hospitals in various parts of the country. Our bill granting scholarship to medical students has passed into law as Republic Act No. 11509, or the Doktor Para sa Bayan Act.

Through dialogue with business leaders and financial advisers, the Senate is also keeping track of the effect of the pandemic on the economic growth of our country.

We have legislated, and continue to legislate, on improving financial benefits to medical workers and easing tax incidence on businesses. We have passed a law to suspend, for a certain period, the increases in the contribution to the Social Security System.⁴

The passing of the Corporate Recovery and Tax Incentives for Enterprises Act (or the CREATE Act)⁵, for example, grants tax relief for companies in the red.

Your Senate also worked in amending the Retail Trade Liberalization Law, which is now pending in the Bicameral Conference Committee. We have, up to this time, been in the process of discussing the Public Service Act, which we shall continue to do when session resumes.

Nais ko rin po sanang ibahagi sa ating kababayan na maliban sa mga pang-medikal at pang-ekonomiyang usapin, nakikipag-ugnayan din ang inyong Senado sa mga dalubhasa sa sikolohiya upang tapatan ng lunas ang lungkot na dala ng social distancing at iba pang dagok sa ating buhay.

We hope to reach out and look towards our cultural agencies to fill the void by lifting our national sprit.

There are other laws that your Senate passed in the 2nd Regular Session of this Congress. For brevity of this speech, may I ask the Secretariat to insert the list into the records.

All the Senate's accomplishments that this representation has mentioned will not be possible without the unwavering service and dedication of all the Senate staffers—both from the offices of the Senators and from the Secretariat. My utmost and fervent gratitude to all of you. As well as, of course, to my dear colleagues for your continued support and for always being one with me in the pursuit of coming up with legislations that are in the interest of the people, fair, and reasonable.

Mga kababayan ko, alam nating sa ngayon, ang pagbabakuna ang nakikitang pangunahing sagot sa

pandemya. Sa usaping medikal, ito ang panangga sa pagkakasakit at impeksiyon. Ang pagbabakuna sa ating komunidad ang susi sa lubos na pagbubukas ng ekonomiya. Pangalagaan natin at pagtuunan ng pansin ang programang ito.

We often think that our government is not acting fast enough. There may be some truth to the statement. But let me put it in context: in extraordinary times such as this—where there are so many unknowns—no government, not even the most advanced country in the world, can act fast enough.

I say this not as an excuse, but as an exhortation to be patient. *Hindi ko nais na isawalang bahala ang inyong puna, kung mayroon man. Hangad ko lang na habaan natin ang ating pisi at pasensiya.*

As Senate President, I give you a simple promise; We, in the Senate, will do our best.

I would like to think that similar to the fable of the tortoise and the hare, we will win over the pandemic not because of how fast we run, but how wise we are at strategizing for the win.

Nakikiusap ako sa ating lahat—sa mga mamamayan ng ating bayan—sa mga kapwa kong naglilingkod sa ibat't ibang sangay ng pamahalaan, patuloy tayong mag-ugnayan tulad ng isang bansa.

Huwang tayong magpapadala sa panimdim. Buksan natin ang ating mga kalooban sa pagtulong sa kapwa.

Magpasalamat tayo sa ating buhay ano mang antas ang kinalalagyan nito.

Ipunin natin ang ating pag-asa, iwaksi ang pangamba, huwag maglimayon sa kalungkutan, ipagdasal ang mga mahal nating yumao. Sabay nating harapin ang liwanag ng mas magandang bukas. Pinatumba man tayo ng pandemya, alam kong lalaban ang bayang Pilipinas. Babangon itong mas malakas, at mas matatag at mas hihigitan ang lugmok ng kanyang pagkakadapa.

SURVEY OF SENATE ACCOMPLISHMENTS

SURVEY OF SENATE ACCOMPLISHMENTS EIGHTEENTH CONGRESS Second Regular Session (July 27, 2020 – June 4, 2021)

AGRICULTURE

R.A. No. 11511 An Act Amending Republic Act No. 10068 Or The Organic Agriculture Act of 2010 (S. No. 1318/ H. No. 6878) [December 23, 2020]

The law establishes a Participatory Guarantee System (PGS), which refers to a locally-focused quality assurance system that is developed and practiced by people actually engaged in organic agriculture.

The law also creates the National Organic Agriculture Program–National Program Coordinating Office (NOAP-NPCO) under the Department of Agriculture (DA), which will serve as the planning and administrative secretariat of the National Organic Agriculture Board (NOAB) and coordinating office of the NOAP.

Furthermore, the amendatory law also restructures, strengthens, and empowers the Bureau of Agriculture and Fisheries Standards (BAFS), which will provide technical assistance to the NOAB and the NOAP-NPCO. The BAFS will also be tasked to formulate and update standards relevant to organic agriculture; issue accreditation to Organic Certifying Bodies (OCBs); conduct inspections on compliance of Participatory Guarantee System (PGS) groups with the Philippine National Standards for organic agriculture, and publish at least once a year the list of compliant PGS groups. The law defines Organic Certifying Body (OCB) as a legal entity accredited by a government agency to perform inspection and certification activities. OCB is responsible for verifying that a product sold or labeled as "organic" is produced, processed, prepared, or handled according to relevant guidelines.

This Act appropriates an annual budget amounting to P1 Billion, with specific allocations such as shared facilities, seeds development, distribution of planting materials and animals, feeds for aquaculture, soil amendments and bio-control agents, extension and training, socialized credit, small scale irrigation system, research for development, and marketing and promotion.

R.A. No. 11524 An Act Creating the Coconut Farmers and Industry Trust Fund, Providing for Its Management and Utilization, Reconstituting for The Purpose the Philippine Coconut Authority Board, And for Other Purposes (S. No. 1396/H. No. 8136) [February 26, 2021]

The law creates the Coconut Farmers and Industry Trust Fund to allow coconut farmers and workers to directly benefit from coco levy funds. The law also reconstitutes the Philippine Coconut Authority (PCA) to reflect the proposed membership of the Trust Committee tasked to manage the coconut levy trust fund. The trust fund will be utilized for coconut farm improvements to encourage self-sufficiency among farmers, programs for shared facilities and scholarship programs and initiatives for the empowerment of coconut farmers' organizations and their cooperatives. The trust fund will also be appropriated through the General Appropriations Act. The PCA Board shall be appointed by the President and shall be composed of the following:

1. The Secretary of the Department of Agriculture (DA), as Chairperson;

2. The Secretary of the Department of Finance (DOF), as Vice Chairperson;

3. The Secretary of the Department of Budget and Management (DBM);

4. The Secretary of the Department of Science and Technology (DOST);

5. The Secretary of the Department of Trade and Industry (DTI);

6. The Administrator of the Authority; and

7. Three (3) members from the coconut farmers sector (one each from Luzon, Visayas, and Mindanao).

In the formulation of the Coconut Farmers and Industry Trust Plan, the PCA shall be guided by the following objectives:

- 1. Increased incomes of coconut farmers;
- 2. Poverty alleviation and social equity; and
- 3. Rehabilitation and modernization of the coconut industry towards farm productivity.

A Trust Fund Management Committee shall be created comprising authorized representatives from the DOF and DOJ which shall be responsible for setting the Investment Strategy of the Trust Fund. The Committee shall submit to the President a report on the disposition of the Coconut Levy Assets on a semiannual basis.

R.A. No. 11547 An Act Declaring the City of Davao as The Chocolate Capital of the Philippines and The Entire Region X1 (Davao Region) As The Cacao Capital of the Philippines (S. No. 1741/H. No. 7460) [May 27, 2021]

This law declares Davao City as the Cacao and Chocolate Capital of the Philippines as it recognizes the city as the country's biggest producer of cacao. Further, it also recognizes the city's vital contribution in making the Philippines world-renowned and sought after by chocolate makers from the US, Japan and Europe This law also seeks to garner government support not only to maintain, promote, and protect the country's cacao industry, but most importantly, to ensure its sustainability for the benefit of farmers and other stakeholders.

S. No. 1927 An Act Authorizing the Department of Agriculture to Use the Annual Tariff Revenues in Excess of P10 Billion, Under Republic Act 11203 Or "An Act Liberalizing the Importation, Exportation and Trading of Rice Lifting for The Purpose the Quantitative Import Restriction On Rice, and for Other Purposes," For Direct Cash Assistance to Farmers Owning One (1) Hectare or Less of Rice Land Until 2024

The bill seeks to authorize the Department of Agriculture (DA) to use the annual revenues in excess of P10 Billion under the Rice Tariffication Act, for direct cash assistance to rice farmers owning one hectare and below until 2024. This is in view of the current state of declining palay prices and effects of the COVID-19 pandemic. The bill also requires that the DA and the Bureau of Customs shall submit separate reports to Congress, at year end, through the Committee on Agriculture, on the remittance of funds and the actual fund disbursement for the year, respectively.

APPROPRIATIONS

R.A. No. 11518 An Act Appropriating Funds for The Operation of the Government of the Republic of the Philippines from January One to December Thirty-One, Two Thousand and Twenty-One, And for Other Purposes (H. No. 7727) [December 28, 2020]

This Act provides the amount of P4.506 Trillion for the national budget of the Philippines in 2021. This amount is nine point nine percent (9.9%) higher than the 2020 national budget,

and represents twenty-one point eight percent (21.8 %) of the projected 2021 gross national domestic product (GDP). In terms of sectoral allocation, the social services sector gets the highest share of the national pie (37%), followed by economic services (29.4%), general public services (16.6%), debt service (12.4%), and defense (4.6%).

In expense allocation, the budget for personnel services garners the largest appropriation, for P1.299 Billion. Below is the table showing appropriation regarding expense class:

The top ten departments receiving the largest allocation are the following:

1. Education (includes DepEd, SUCs, CHED, TESDA), P751.7 Billion or 16.7% of the 2021 budget;

2. Department of Public Works and Highways (DPWH), P695.7 Billion or 15.4% of the budget;

3. Department of Interior and Local Government (DILG), P695.7 Billion or 5.5% of the budget;

4. Department of Health (includes P71.4 Billion budget of PhilHealth), P210.2 Billion or 4.7% of the budget;

5, Department of National Defense (DND), P205.8 Billion or 4.6% of the budget;

6. Department of Social Welfare and Development (DSWD), P176.9 Billion or 3.9% of the budget;

7. Department of Transportation (DOTr), P87.9 Billion or 2% of the budget;

8. Department of Agriculture (DA), P71 Billion or 1.6% of the budget;

9. Judiciary, P45.3 Billion or 1% of the budget, and

10. Department of Labor and Employment (DOLE), P37 Billion or .8% of the budget.

R.A. No. 11519 An Act Extending the Availability of Appropriations Under Republic Act No. 11494, Otherwise Known as The "Bayanihan to Recover as One Act" (H. No. 8063) [December 29, 2020]

This act extends the availability of appropriations authorized under Republic Act No. 11494 or the *Bayanihan to Recover as One Act*, which includes among others, automatic appropriations of new programs, activities and projects (P/A/Ps) under Section 4 of said measure. The release, obligation, and disbursement of funds on these P/A/Ps shall be until June 30, 2021. However, the appropriations from reprogrammed, reallocated and realigned savings in RA No. 11465 or the GAA 2020 shall be valid for release, obligation, and disbursement under the provisions of GAA 2020 as long as the use of these funds are in accordance with Section 4 of the *Bayanihan to Recover as One Act.*

The special and general provisions of the 2020 GAA shall be suppletory to *Bayanihan to Recover as One Act*.

The balances of fund transfers between agencies, instrumentalities and government-owned and-controlled corporations (GOCCs) that are obligated but remain unused, unutilized, unspent, and undisbursed as of June 30, 2021 shall revert to the unappropriated surplus of the General Fund. Any balances of fund transfers in the books of the Philippine International Trading Corporation (PITC) shall also revert to the unappropriated surplus of the General Fund upon the effectivity of this measure.

The authority of the President to exercise powers granted under RA No. 11494 or *Bayanihan to Recover as One Act,* including the authority to reprogram, reallocate, and realign other items in the appropriations of the Executive Department in the 2020 GAA, shall be valid only until December 19, 2020.

The validity of advises of allotments issued by DBM for fund releases charged against Section 10 (Standby Fund) of *Bayanihan to Recover as One Act* shall be extended until June 30, 2021 in accordance with Section 1 of this measure. Likewise, the fund releases to LGUs and GFIs for P/A/Ps cited in the same section shall extend until June 30, 2021. These fund releases shall be governed by conditions stipulated under Section 10 of same law.

However, fund releases to LGUs and GFIs sourced from savings in the 2020 GAA shall be governed only by applicable provisions of GAA 2020.

R.A. No. 11520 An Act Extending the Availability of The 2020 Appropriations to December 31, 2021, Amending for The Purpose Section 60 Of The General Provisions of Republic Act No. 11465 Or The General Appropriations Act of Fiscal Year 2020 (H. No. 6656) [December 29, 2020]

This Act amends Section 60 of GAA 2020 on provision of the Cash Budgeting System. It provides that all appropriations in GAA 2020 including budgetary support to GOCCs shall be available for release and disbursement until December 31, 2021.

Likewise, appropriations for financial assistance to local government units (LGUs) released during FY 2020 shall be available for disbursement until December 31, 2021. However, statutory shares of LGUs (like the internal revenue allotment) shall be available for obligations and disbursement until fully expended.

After said validity period, all unreleased appropriation shall lapse; unexpended or undisbursed funds shall revert to the unappropriated surplus of the General Fund. Said funds shall not be available for expenditure except by subsequent legislative enactment.

Another set of funds that shall revert to the unappropriated surplus of the General Fund are the obligated balances of fund transfers between agencies, instrumentalities and GOCCs, but are unused, unutilized, unexpended, and undisbursed as of December 31, 2021.

Another source of unappropriated surplus of the General Fund can be derived from balances of fund transfers in the books of the Philippine International Trading Corporation (PITC). This Act stipulates that the PITC shall not be allowed to accept outsourcing requests from other agencies or enter into agreements with instrumentalities and/or GOCCs. The law also cites the following items as valid for obligation until December 31, 2021:

- 1. For FY 2020, appropriations for infrastructure capital outlays including subsidy releases to GOCCs for infrastructure projects; However, completion of construction, inspection, and payment shall be made not later than December 31, 2021.
- 2. Appropriations for MOOE and other capital outlay items; However, delivery, inspection, and payment shall not be later than December 31, 2021.

The DBM is authorized to issue guidelines for the effective implementation of the cash budgeting system. Further, it is also mandated to submit a report on the releases, obligations and disbursements to the Speaker of the House of Representatives, the House Committee on Appropriations, the President of the Senate, and the Senate Committee on Finance.

BANKING AND FINANCIAL REFORM

R.A. No. 11521 An Act Further Strengthening the Anti-Money Laundering Law, Amending for The Purpose Republic Act No. 9160, Otherwise Known as The "Anti-Money Laundering Act of 2001", As Amended (S. No. 1945/ H. No. 7904) [January 29, 2021]

This Act expands the coverage of the law on persons and transactions that may be used for money laundering activities in relation to financing terrorism and proliferation of weapons of mass destruction. It expands the functions of the Anti-Money Laundering Council (AMLC) and prescribes lawful processes for investigations and imposition of sanctions on violation of the Anti-Money Laundering Law.

The measure covers the following persons:

(1) real estate developers and brokers,

(2) persons covered under Section 3(a)(9) of this Law or real estate developers and brokers with transactions involving an amount in excess of P7.5 Million or its equivalent in any currency, in a single transaction,

(3) offshore gaming operators and their service providers that are supervised, accredited or regulated by the Philippine Amusement and Gaming Corporations (PAGCOR).

This law also covers the following transactions:

(a) transaction in cash or monetary instrument in excess of P500,000.00 within one banking day,

(b) Single casino transaction in excess of P5 Million or its equivalent in any currency.

"Suspicious" transactions and unlawful activities are also covered under this law and are listed, among others as:

- 1) a transaction where there is no underlying legal or trade obligation, purpose or economic justification,
- 2) where client is not properly identified,
- 3) the amount involved is not commensurate with the business or financial capacity of the client,
- 4) fraudulent practices and violations of RA 8799 or the Securities Regulation Code of 2000,
- 5) violation of Section 19 (a)(3) of RA 10697 or Strategic Management Act in relation to proliferation of weapons of mass destruction pursuant to UN Resolution 1718 of 2006 and 2231 of 2015.

The law mandates that AMLC should apply for a search and seizure order as well as issuance of *subpoena ad testificandum* and *subpoena duces tecum* from a competent court in the conduct of its investigation. It shall apply financial sanctions, such as *ex parte* freeze on funds and assets that are owned, controlled and generated by entities listed under said UN Resolution 1718 and 2231.

The freeze order may be issued immediately by the Court of Appeals (CA) and be effective for twenty (20) days, during which said court shall conduct a summary hearing whether to lift, modify the freeze order or to extend the period of its effectivity. The freeze shall not exceed six (6) months, and when there is no case filed against the involved person within said period, the freeze is considered lifted. There shall be no TRO or writ of injunction on the freeze, except by the Supreme Court. The AMLC shall also have the power to freeze, without delay, if this concerns proliferation of weapons of mass destruction as per said UN Resolution. Within twenty (20) days from its issuance, the aggrieved party may file petition with the CA, to determine the basis of the freeze, in accordance with the principle of effective judicial protection. However, the aggrieved person may draw sums from the frozen funds or assets for his and his family's monthly sustenance as determined by the AMLC. He shall also draw from the said funds or assets to finance the services of his counsel and his or his family's medical needs.

For its part, the AMLC may initiate civil forfeiture proceedings such as the *freeze* so as not to dissipate said funds or assets. No TRO or writ of injunction may be issued against such freeze except from the CA or Supreme Court.

This law also provides that AMLC shall not intervene in the independent operation of the Bureau of Internal Revenue (BIR). However, AMLC may coordinate with the BIR on investigations

on violations of Section 254 of NIRC, as amended, as predicate offense to money laundering.

In the course of its investigations, the AMLC and its secretariat shall protect the information it gathered and not reveal these even after their separation from the AMLC.

The law provides for sanctions on breach of information security and confidentiality. This may take the form of imprisonment from three (3) to eight (8) years and a fine of not less than P500, 000.00 but not more than P1 Million. If the offender is a public official or employee, he shall be temporarily or forever barred from public office, aside from suffering the imprisonment and fine as aforementioned. If the information is published or reported in the media, the responsible reporter, writer, president, publisher, manager, and editor in chief shall also be liable under this Act.

R.A. No. 11523 An Act Ensuring Philippine Financial Industry Resiliency Against the COVID-19 Pandemic (S. No. 1849/H. No. 6816) [February 16, 2021]

This law, also known as the Financial Institutions Strategic Transfer (FIST) Act, aims to improve the financial system by mobilizing the potential value of resources embedded but lying dormant in Non-Performing Assets (NPA) and Non-Performing Loans (NPL). Mobilizing the value of these resources can generate liquidity that can ease the flow of much needed funds to reverse a sluggish economy into one of steady growth and stability.

This act authorizes the creation of Financial Institutions Strategic Transfer Corporation (FISTC) to achieve said objective. The FISTC is a stock corporation organized in accordance with RANO. 11232 (Revised Corporation Code of the Philippines). A FISTC shall not be formed as a one-person corporation. An entity becomes a FISTC upon filing of application for establishment and registration at the Securities and Exchange Commission (SEC) and its subsequent approval. Filing of application shall be within 36 months from the effectivity of this law. The FISTC shall submit a FISTC Plan to SEC within a period prescribed by latter. A complete plan shall contain information required and listed under Section 8 of this law, some of which are: (1) investment policies of the FISTC, (2) features of the Investment Unit Instruments (IUIs)-including the specific amounts issued and to be issued, (3) details of distribution policies, (4) methods for the liquidation and distribution of assets to holders of IUIs, and (5) name of external auditor of the FISTC; the presence of an external auditor was especially cited in the law. FISTC has to acquire the plan's Certificate of Approval from SEC in order that it can sell or issue the IUIs as stated in the plan. FISTC can only sell or issue IUIs to "permitted" investors as defined in Section 11 of this act.

A FISTC shall have a minimum authorized capital stock of P500 Million, with a minimum subscribed capital stock of P125 Million, and a minimum paid-up capital of P31.250 Million.

Where land and foreign equity participation are concerned, the FISTC shall comply with the provisions of the Constitution and the minimum capital requirements in accordance with RA No. 7042 (Foreign Investments Act), as amended.

The FISTC's functions are that of acquiring NPAs and NPLs from financial institutions (FIs) and transfer or sell these to third parties, thus earning revenues, interest and profits. It can buy or transfer shares issued by a borrower of the FIs. It can also lease acquired assets and thus collect rents from it. A FISTC can restructure NPLs or convert it to equity.

FISTCs shall also enjoy incentives and tax exemptions among which are the following: (1) documentary stamp tax, (2) capital gains tax, (3) creditable withholding income taxes, (4) valueadded tax on the transfer of NPAs as may be imposed under Title IV of NIRC 1997. As in any corporation, FISTC shall keep books of accounts and records. It shall appoint an external auditor that is acceptable to SEC. The latter, the BSP and the BIR may examine the books of accounts and records of FISTC at reasonable hours on business days after due notice.

The FISTC shall set up a financial consumer protection mechanism taking into consideration provisions of existing laws, rules and regulations protecting the borrower. Financial consumer mechanism shall include standards of disclosure and transparency, conflicts of interests, protection of client information, fair treatment, prevention of over-indebtedness and exhaustion of all remedies, among others.

A person who avails of tax exemptions and privileges under this law, but is not entitled to, shall refund the government double the amount of tax exemptions and privileges availed under this law plus interest of 12% per year from the date prescribed for its payment until full payment.

Moreover, the violator shall be fined P100,000.00 to not more than P200,000.00 or imprisonment of not less than six (6) years nor more than 12 years, or both. If the offender is an alien, he shall be immediately deported without further proceedings after payment of aforementioned penalties. If the offender is a public official or employee, he shall be disqualified from public office and suffer the abovementioned penalties and sanctions.

A Joint Congressional Oversight Committee (JCOC) shall be formed with five (5) members each from the Senate and the House of Representatives. It shall be cochaired by the chairpersons of the Senate's Committee on Banks, Financial Institutions and Currencies, and the House Committee on Banks and Financial Intermediaries. The Senate President and the Speaker of the House shall designate the other four (4) members of the JCOC from their end.

This act repeals RA 9182 or the Special Purpose Vehicle (SPV) Act of 2002. Entities specified under SPV 2002 can avail of the privileges under the FIST Act.

CHILDAND YOUTH

S. No. 1373 An Act Protecting Children by Prohibiting and Declaring Child Marriage as Illegal and Providing Programs and Penalties Thereof

The bill considers the act of child marriage a public crime, and penalizes any person who facilitates and solemnizes this union with the penalty of *prision* mayor in its medium period and a fine of not less than P40,000.00.

Child Marriage is defined as any marriage entered into and solemnized in civil or church proceedings, or in any recognized traditional, cultural, or customary manner, where one or both parties are persons below 18 years of age, or those unable to fully take care of themselves or protect themselves from abuse, exploitation, or discrimination because of a physical or mental disability or condition.

The bill also introduces a culturally-appropriate program and services that will be responsive to the needs of those who will be affected by this law. The Department of Social Welfare and Development (DSWD) shall be the lead duty-bearer in the formulation of such program and services, and in the implementation of the law.

S. No. 2124 An Act to Further Empower the Members of the Sangguniang Kabataan (SK) By Amending Certain

Provisions in Republic Act No. 10742, Otherwise Known as The 'Sangguniang Kabataan Reform Act of 2015'

The bill amends RA 10742, otherwise known as the Sangguniang Kabataan Reform Act of 2015. It grants a monthly honorarium to Sangguniang Kabataan (SK) members, secretaries, and treasurers chargeable against SK Funds, subject to guidelines issued by the DBM. The Personnel Service allocation, however, shall not exceed 25% of the funds which would allow the bulk of the SK funds to be dedicated to their projects and programs for the youth. LGUs will also be allowed to provide additional honorarium to the SK Chairperson and its members via local ordinance.

The bill also provides additional qualifications for the SK Treasurer to ensure that only competent individuals are able to take this position. The SK Treasurer is required to have an educational and/or career background relating to Business Administration, Accountancy, Finance, Economics, or Bookkeeping. Only if no person meets the required educational background can the SK Chairperson consider other suitable nominees. These SK Treasurers are also required to undergo mandatory Bookkeeping training from TESDA prior to assuming office and they are required to be bonded officers.

The bill also provides guidelines on how SK funds may be used. In particular, such funds can be utilized for student stipends, book and education allowances, sports and wellness projects, skills training, OJT assistance, cash-for-work, livelihood assistance, environment conservation, calamity preparedness, and capacity building. Meanwhile, a maximum of 15% of these funds must be set aside for the mandatory and continuing training of the SK.

Moreover, the measure grants additional privileges to SK officials, such as exemption from taking any of the National

Service Training Program (NSTP); entitlement to appropriate Civil Service Eligibility provided that the official has rendered a full term of office.

The SK are mandated to (1) formulate and approve internal rules; (2) appoint its secretary and treasurer; and (3) set the schedule for regular SK meetings and SK assemblies within 60 days from their assumption to office. Every province, city or municipality shall appoint a local youth development officer, with the rank of at least division chief.

The measure also mandates LGUs to appropriate no less than one percent (1%) of their annual budget for the Local Youth Development Office.

S. No. 2209 An Act Strengthening Protections Against Online Sexual Abuse and Exploitation of Children, Amending for This Purpose Republic Act No. 9775 Or The Anti-Child Pornography Act of 2009; Amending for This Purpose Republic Act No. 9995, Or The Anti-Photo and Video Voyeurism Act of 2009, Providing Penalties for Its Violations, And for Other Purposes

The proposed Special Protections against Online Sexual Abuse and Exploitation of Children (OSAEC) Law provides special protection to children from all forms of sexual violence, abuse and exploitation especially those committed with the use of information and communications technology. The measure provides sanctions for violators, as well as identifies programs for the prevention, deterrence, and intervention that will help prevent online sexual abuse and exploitation of children.

Child Sexual Abuse, as defined in the bill, is any form of communication through any platform or format, or any physical interaction between a child and any person when the child is being used for any act or activity inducing sexual stimulation or for the purpose of sexual gratification, regardless of the consent of the victim.

Child Sexual Exploitation, meanwhile, is defined as sexual abuse and/or other sexualized acts using children that involve an exchange of some kind, including money, affection, food, drugs, shelter, protection, favor, or influence.

The Online Sexual Abuse and Exploitation of Children (OSAEC) referred in this bill is the use of digital or analog communication as a means to abuse and exploit children sexually. This includes the production, dissemination, and possession of Child Sexual Abuse and Exploitation Materials (CSAEM); online grooming of children for sexual purposes; sexual extortion of children, sharing image-based sexual abuse; commercial sexual exploitation of children through online prostitution; and live-streaming of sexual abuse, with or without the consent of the victim.

The bill considers offenses under this Act as public crimes. Therefore, any person who has personal knowledge of the commission of these crimes, such as the victim-survivor, the parents, spouse, siblings, legal guardian, officer, or social worker or representative of a licensed child-caring institution, officer or social worker of the DSWD, Philippine National Police (PNP) and National Bureau of Investigation (NBI), barangay chairperson and at least three (3) concerned citizens where the violation occurred, may file a complaint against the offender.

The bill also prohibits the entry into the Philippines of all convicted offenders of OSAEC or similar or equivalent crimes in other jurisdictions, or those aliens reported to or being monitored by the Philippine law enforcement authorities for conducting OSAEC activities. The bill proposes the creation of a National Coordination Center Against OSAEC (NCC-OSAEC) to be formed under the Inter-Agency Council Against Trafficking (IACAT, RA No. 9208). The bill also proposes the amendment of RA No. 9208 by providing the additional mandate of addressing cases falling under OSAEC; and the addition of the Secretary of the Department of Education and the Secretary of the Department of Information and Communication Technology as members of the IACT.

Further, the bill provides penalties for the commission of crimes under this proposed law, from an imprisonment of six (6) months to life imprisonment and; a fine ranging from P500,000.00 to P5 Million.

Moreover, the bill provides for the creation of the OSAEC Offenders Registry. The registry shall contain the list of adult individuals, Filipino nationals and foreigners, with their personal information, who were convicted of OSAEC and other sexual offenses against children.

CITIZENSHIP

R.A. No. 11543 An Act Granting Philippine Citizenship to Kakou Ange Franck Williams Kouame (H. No. 7332) [May 18, 2021]

The law grants Philippine citizenship to Kakou Ange Franck Williams Kouame, with all the rights, privileges, and prerogatives, as well as the duties and obligations appurtenant thereto under the Constitution and other laws of the Republic of the Philippines.

Mr. Kouame shall take the Oath of Allegiance to the Republic of the Philippines before an officer duly authorized to

administer the same and said Oath shall be registered with the Bureau of Immigration.

H. No. 8631 An Act Granting Philippine Citizenship to Bienvenido Morejon Marañon

The bill seeks to grant Philippine citizenship to Bienvenido Morejon Marañon, with all the rights, privileges and prerogatives, as well as the duties and obligations appurtenant thereto under the Constitution and the laws of the Republic of the Philippines.

Mr. Marañon shall take the Oath of Allegiance to the Republic of the Philippines before an officer duly authorized to administer the same and said Oath shall be registered with the Bureau of Immigration.

CIVIL SERVICE, GOVERNMENT REORGANIZATION AND PROFESSIONAL REGULATION

R.A. No. 11517 An Act Authorizing the President to Expedite the Processing and Issuance of National and Local Permits, Licenses and Certifications in Times of National Emergency (S. No. 1844/H. No. 7884) [December 23, 2020]

The law authorizes the President of the Philippines, in times of national emergency, to accelerate and streamline regulatory processes and procedures for new and pending applications for permits, licenses, clearances, and certifications including shortening the periods; suspend or waive the requirements in securing such permits, licenses, clearances, certifications, notwithstanding any law to the contrary; and prescribe to make permanent, the streamlined regulatory processes and procedures, suspension or waiver of the requirements in securing permits. The authority granted to the President shall not undermine the existing procedures and processes under applicable laws meant to protect the environment especially those which aim to safeguard protected areas and the environmentally critical areas.

The law covers all agencies of the Executive branch, including departments, bureaus, offices, commissions, boards, councils, government instrumentalities, government-owned and -controlled corporations, and local government units.

The President is also authorized to suspend or remove any government official or employee who performs acts contrary to law, upon determination of a competent body.

S. No. 643 An Act Granting Night Shift Differential Pay to The Government Employees Including Those in Government-Owned or Controlled Corporations and Appropriating Funds Therefor

The bill proposes to grant night shift differential pay to government employees under Salary Grade 1 to Salary Grade 24, including those in the government-owned and controlledcorporations, whether the nature of their employment is permanent, contractual, temporary, or casual.

The employees shall be paid night shift differential at a rate not exceeding 20% of the hourly basic rate for each hour of work performed between the hours of 6:00pm and 6:00am of the following day. The night shift differential pay will be in addition to and will not in any way diminish whatever benefits and allowances the government employees enjoy.

The following government employees are not covered by this bill:

- a) Government employees whose schedule of office hours fall between 6:00 a.m. to 6:00 p.m. However, services rendered beyond the regular eight-hour work schedules are paid overtime pay in accordance with existing laws.
- b) Government employees whose services are required, or are on-call, twenty-four (24) hours a day such as uniformed personnel of the Armed Forces of the Philippines (AFP), the Philippine National Police (PNP), the Bureau of Jail Management and Penology (BJMP), the Bureau of Fire Protection (BFP), and other similarly situated, as may be determined by the Civil Service Commission (CSC) and the Department of Budget and Management (DBM).

The amount necessary for the effective implementation of this bill shall be funded as follows:

a) For the national government entities, the initial amount shall be charged against existing appropriations for the purpose of departments, bureaus, offices, and agencies concerned.

Thereafter, such sum as maybe necessary for the continuous implementation of this bill shall be included in the annual General Appropriations Act;

b) For local government units, the amount shall be charged against their respective funds; and for government-owned or controlled corporations and their subsidiaries, the amount shall come from their respective corporate funds.

S. No. 1092 An Act Institutionalizing the Grant of a Teaching Supplies Allowance for Public School Teachers and Appropriating Funds Therefor The bill authorizes the grant of teaching supplies allowance for the purchase of teaching supplies and materials, and for the conduct of various learning delivery modalities (LDMS) in the amount of P5,000.00 per teacher for the school year 2021-2022 and 2022-2023.

It further grants the amount of P7,500.00 per teacher for the school year 2023-2024; and P10,000.00 per teacher for the school year 2024-2025, and thereafter. This allowance shall be exempt from income tax.

The grant of the cash allowance covers teachers who are engaged in teaching public basic education, consistent with the learning modalities recognized by the Department of Education (DepEd).

The amount necessary for the grant of teaching supplies allowance for teachers shall be charged against the appropriations of the DepEd under the General Appropriations Act (GAA).

The bill also mandates the Secretary of Education to conduct a periodic review of the teaching supplies allowance, taking into account the current prices of teaching supplies and materials. The Secretary may recommend the necessary increase in the amount of the allowance, if warranted.

ECONOMY

R.A. No. 11494 An Act Providing for Covid-19 Response and Recovery Interventions and Providing Mechanisms to Accelerate the Recovery and Bolster the Resiliency of the Philippine Economy, Providing Funds Therefor, And for Other Purposes (S. No. 1564/H. No. 6953) [September 11, 2020] This law institutes a set of response and recovery interventions for the whole nation in a state of national emergency due to the Covid-19 pandemic. It installs a mechanism for testing, tracing, treatment and isolation of suspect-infected or infected individuals and grant of assistance to vulnerable sectors like displaced workers and their families, returning OFWs, health workers and small businesses.

The law specifies the role of LGUs, national government agencies like PhilHealth and government financial institutions (GFIs) and banks as well as other sectors in this massive aid initiative.

The measure also creates a national referral system that provides patients a fast and efficient way to locate and avail services of hospitals, clinics, isolation centers, ambulance transport, and the like. It declares tax exemption of retirement benefits in the private sector as well as tax exemption on the sale, barter or exchange of shares of stocks listed and traded through initial public offering. Moreover, it grants appropriation for a standby fund that shall finance these interventions and identifies the sources of the fund.

This law also mandates the President to submit a monthly report to Congress and the Commission on Audit (COA) on all actions in the implementation of this measure, including the terms and conditions of loans committed by the government to fund programs and projects pursuant to this Act. A Joint Congressional Oversight Committee (JCOC) composed of four (4) members from each House shall be formed to determine that acts, orders, rules, and regulations are within the bounds provided by this measure.

Under the law, an emergency subsidy of P5,000.00 to P8,000.00 shall be granted to low-income households under granular lockdown as well as those who became unemployed or involuntarily separated from work because of the imposed

lockdown. This benefit shall also be given to OFWs who were repatriated due to pandemic-related work stoppage in their host countries as well as those whose deployment were suspended.

A P10-Billion fund shall be allotted for testing and procurement of Covid-19 medication and vaccine.

Health workers shall be entitled to a special risk allowance; hazard pay (per Magna Carta for Health Workers) as well as active hazard duty pay. The law mandates that they will be compensated in case they contract the infection or die from it.

Local Government Units (LGUs) shall be authorized to realign their local funds and channel these to COVID-19 responses. These includes, but not limited to, the development fund, Gender and Development Fund, Sangguniang Kabataan Fund, Special Education Fund, and other local funds, including unutilized or unreleased subsidies and transfers.

National government agencies are also encouraged to channel unutilized funds and savings to COVID-19 response.

The DBM and the Bureau of Treasury (BTR) shall automatically, and completely, release any adjusted or remaining shares of LGUs in national wealth and National Tax Allotment (NTA) pursuant to Section 286 of Republic Act 7160 (Local Government Code of 1991). A standby fund is also available for the government agencies to institute COVID-19 responses. Amounts are specified for the construction of field hospitals, quarantine facilities and expansion of government hospitals throughout the country; the Department of Labor and Employment (DOLE) can access this fund to finance their programs for displaced workers, both domestic and OFWs; government financial institutions (GFIs) and the banking industry can avail of capital infusion through this standby fund. Government financial institutions (GFIs) and banks are enjoined to make credit available to productive sectors especially in the countrysides, by lowering lending rates of interest. Regulatory agencies are also encouraged to decrease the reserve requirements of banks and channel accrued funds to COVID-19 response. Further, the law directs the Land Bank of the Philippines (LBP) and the Development Bank of the Philippines (DBP) to introduce a low interest or a "flexible term" loan program for operating expenses to be made available to affected businesses.

This measure also highlights the role of information and communications technology (ICT) in the activities under the new normal and way of living amidst the pandemic. ICT cuts across all sectors and facilitates processes in both private and government entities. Thus, the law provides funds to encourage all the concerned agencies to come up with measures to partner with internet and communication service providers to accelerate the building of infrastructure, the development of software and wireless technologies and the increase of internet speed and ensure its stability throughout the country.

R.A. No. 11510 An Act Institutionalizing the Alternative Learning System in Basic Education for Out-Of-School Children in Special Cases and Adults and Appropriating Funds Therefor (S. No. 1365/H. No. 6910) [December 23. 2020]

This Alternative Learning System Act institutionalizes the Alternative Learning System (ALS) as a parallel learning system complementary to the formal education system through the establishment of the Bureau of Alternative Education (BAE) within the Department of Education (DepEd).

The law also expands and strengthens the ALS Program and provides increased opportunities for out-of-school youths, adults, and children in special extreme cases to develop basic and functional literacy, life skills, and pursue an equivalent pathway to complete basic education. It covers those who have been deprived of access to formal basic education due to economic, geographic, political, cultural, and social barriers, including persons with disabilities, indigenous peoples, children in conflict with the law, and learners in emergencies, persons deprived of liberty, migrant workers, and other marginalized sectors of society.

The law mandates the DepEd to regularly conduct ALS A&E Assessments and Certifications as a means to measure and certify competencies of ALS program completers and other learners.

The law further facilitates the recruitment of new ALS teachers and facilitators, and provides the means for professional growth of existing ALS teachers. It mandates the DBM to work with the DepEd and the Civil Service Commission in the creation of teaching positions for ALS teachers and allocate the corresponding salary grades. In addition, the DepEd shall also hire ALS literacy volunteers and instructional managers to be ALS teachers through a contracting scheme to augment the needed human resource requirements for the implementation of ALS programs. ALS teachers are provided with allowances for transportation and teaching aids.

Furthermore, the law mandates the establishment of at least one ALS Community Learning Center (CLC) in every municipality and city throughout the country. Priority should be given to areas where there is limited or no access to formal basic education or high concentration of out-of-school youths, adults, and children in special extreme cases.

The measure empowers the private sector to partner with government in the delivery of ALS services by mandating the formulation of standards for service delivery, including teacher qualifications, teacher deployment, teacher training, remuneration, and system of rewards and incentives which are responsive to the needs and distinct situations of the particular areas serviced by these non-governmental actors.

All DepEd ALS programs are free of charge and collection of all kinds of fees, costs, or charges is prohibited.

Funding of the program shall be charged against the current year's appropriations of the DepEd. Continuous implementation of this Act, including the construction or provision of the ALS CLCs and the payment of transportation and teaching aid allowance for ALS Teachers and Community ALS implementors, shall be included in the annual General Appropriations Act

R.A. No. 11549 An Act Lowering the Minimum Height Requirement for Applicants of the Philippine National Police (PNP), Bureau of Fire Protection (BFP), Bureau of Jail Management and Penology (BJMP), And Bureau of Corrections (BuCor), Amending Republic Act No. 6975, As Amended, Republic Act No. 9263, And Republic Act No. 10575 (S. No. 1563/H. No. 8261) [May 26, 2021]

This law lowers the minimum height requirement to 1.57 meters or 5 feet 2 inches for males, and 1.52 meters or 5 feet for females in the Philippine National Police (PNP), the Bureau of Fire Protection (BFP), Bureau of Jail Management and Penology (BJMP), and the Bureau of Corrections (BuCor).

This measure also automatically waives such requirements for applicants from cultural communities and indigenous groups.

EDUCATIONAL REFORMS

R.A. No. 11509 An Act Establishing a Medical Scholarship and Return Service Program for Deserving

Students, And Appropriating Funds Therefor (S. No. 1520/ H. No. 6756) [December 23, 2020]

The law creates a scholarship and return of service program for qualified students who shall pursue or are currently pursuing a Doctor of Medicine degree in state universities and colleges (SUCs) and private higher education institutions (PHEIs). This measure integrates the graduates of this program into the public health system, to address the lack of medical support for the underprivileged and the population in the underserved, remote and economically underdeveloped areas.

The scholarship grant shall cover the following:

- 1. tuition and other school fees;
- 2. books, supplies and equipment;
- 3. clothing or uniform;
- 4. dormitory or boarding house allowance;
- 5. transportation;
- 6. internship fees, including financial assistance during the required internship period;
- 7. medical review fees and licensure fees;
- 8. annual medical insurance; and
- 9. subsistence or living allowance.

The following are qualified to apply for the scholarship:

1. natural-born or naturalized Filipino citizen residing in the Philippines;

2. graduating student or a graduate of an undergraduate degree course that is a prerequisite for a Doctor of Medicine degree from a CHED-recognized school;

3. have passed the entrance test and other requirements for admission to the Doctor of Medicine degree in the SUC or PHEI where the applicant intends to enroll; and 4. have obtained a National Medical Admission Test (NMAT) score as mandated by CHED and the required cut-off score by the SUC or PHEI where the applicant intends to enroll.

Once accepted in the scholarship program, students should satisfy other requirements such as: carrying a full load per semester; no dropping which will lead to underloading; finishing the program within the prescribed time-frame given by the SUC or HEI; pursuing their internship in a DOH-accredited public facility or hospital; and taking the medical board examination within one year after completing the internship period.

In exchange for the scholarship grant, the new doctor shall serve in a government or public health office or in a government hospital in his/her hometown, province or region or in an underserved municipality as determined by the DOH.

The new doctor shall render the mandatory return service within six (6) years from the time of passing the PLE for those who have availed of a four (4)-year program, and seven (7) years for those who have availed of a five (5)-year program. The doctor shall be required to render one year of service for every year that the scholarship grant is availed of.

The law imposes sanctions for those who fail to satisfy the return of service requirements unless the new physician contracts severe or serious illness in which case she/ he will be unable to perform the service required.

Funding of the program shall be charged against the current year's appropriation of the participating SUC, DOH and CHED.

Continuous implementation of this scholarship grant shall be lodged under the annual scholarship program of SUCs and CHED in the General Appropriations Act (GAA).

R.A. No. 11522 An Act Declaring May 18 Of Every Year as The National Higher Education Day (S. No. 1216/ H. No. 4851) [February 5, 2021]

The law declares the 18th day of May of every year as the National Higher Education Day in commemoration of the founding anniversary of the Commission on Higher Education (CHED).

The law encourages all heads of government agencies and instrumentalities, including government-owned-and-controlled corporation, local government units, public and private educational institutions, employers in the private sector, and industry associations, to afford time and opportunities for their students or employees to engage and participate in any activity conducted within the premises of their schools, offices or establishments in celebration of this day.

R.A. No. 11551 An Act Integrating Labor Education in The Tertiary Education Curriculum (S. No. 1513/H. No. 4466) [May 27, 2021]

The law mandates the integration of labor education topics into selected core general education subjects in the higher education curriculum.

It also decrees integrating labor education into the technical and vocational education and training curriculum through appropriate modules of instructions and other relevant materials crucial to empowering future Filipino workers, employers, and entrepreneurs.

Furthermore, the law mandates the Technical Education and Skills Development Authority (TESDA), with the Department of Labor and Employment (DOLE), to develop appropriate modules of instructions and other relevant materials relating to labor education. S. No. 1907 An Act Instituting Services and Programs for Learners with Disabilities in Support of Inclusive Education, Establishing Inclusive Learning Resource Centers of Learners with Disabilities in All Municipalities and Cities, Providing for Standards, and for Other Purposes

The bill seeks to provide learners with disabilities, access to the general formal education system by providing support services and programs to cater to their special needs.

The Inclusion Policy for Learners with Disabilities in Public and Private Schools expressly prohibits the denial of admission or inclusion of any learner with disability in any public or private basic education school.

To operationalize inclusive education for learners with disabilities nationwide, the bill provides for the implementation of comprehensive inclusionary reforms within the basic education system. Aside from the allocation of significant budgetary and human capital resources, this bill will also institutionalize innovative programs to identify learners with disabilities, assess their unique needs, and provide quality services to address these needs and help them succeed within the framework of the formal education system.

The bill establishes a national network of Inclusive Learning Resource Centers (ILRCs) at the city or municipal level by the DepEd, in collaboration with the local government units (LGUs). The ILRC will serve as a sort of one-stop-shop for the delivery of free support services to learners with disabilities and the local implementation of the various inclusive education programs established by this bill. The ILRC will be staffed by multidisciplinary teams and mobile teams composed of special education teachers, psychologists, guidance counsellors, social workers, interpreters, and other allied medical professionals. The LGUs may also establish satellite ILRCs at the school level.

ILRCs will be in charge of implementing services for the benefit of learners with disabilities within their respective jurisdictions. These services include linguistic solutions for deaf learners' concerns, speech-language pathology and audiology services, interpreting services, intervenor services, psychological services, physical and occupational therapy, recreation, social services, school health services, counselling and rehabilitation services, orientation and mobility services, medical services, and transportation services. ILRCs will also implement two programs: the Child Find System and the Individualized Education Plan.

The bill also mandates the formation of an Advisory Council for Education of Learners with Disabilities, which shall be composed of representatives from various organizations of persons with disabilities and a representative from the academe.

The council will collaborate the DepEd for policy formulation, research, and evaluation.

ENERGY

R.A. No. 11552 An Act Extending and Enhancing the Implementation of the Lifeline Rate, Amending for The Purpose Section 73 Of Republic Act No. 9136, Otherwise Known as The "Electric Power Industry Reform Act of 2001," As Amended by Republic Act No.10150 (S. No. 1877/ H. No. 8145) [May 27, 2021] The law extends, and enhances, the Lifeline Rate, which will end in June 26, 2021, for 30 years. The Lifeline Rate is a socialized pricing mechanism that serves as subsidy for the poor.

Beneficiaries of this law are qualified marginalized endusers defined as household-beneficiaries under Republic Act No. 11310 or the "Pantawid Pamilyang Pilipino Program (4Ps) Act"

S. No. 1296 An Act Establishing the Philippine Energy Research and Policy Institute, Defining Its Objectives, Powers, And Functions, Providing Funds Therefor, And for Other Purposes

The bill seeks to create a Philippine Energy Research and Policy Institute (PERPI), an agency attached to the University of the Philippines (UP) Diliman. It shall be composed of an Executive Director, which shall be the head of the Institute and appointed by the UP President. The Executive Board shall be composed of seven (7) members with at least one (1) representative from the fields of engineering, law, science, statistics, economics, and public health, either from the academe or the private sector. The members of the Board shall also be chosen by the UP President and shall each have a term of three (3) years.

PERPI will be tasked to conduct multidisciplinary energy research and policy development on energy issues, develop cutting-edge technologies, create training programs, and serve as partner for the government during the energy policy-making process. It proposes P200 Million as the initial fund allocation to support the research policy development and training programs of the Institute.

The Institute shall be entitled to all tax exemptions enumerated under Section 25 of RA No. 9500 or the University of the Philippines Charter of 2008, as amended by RA No. 10963, otherwise known as the Tax Reform for Acceleration and Inclusion Act.

S. No. 1955 An Act Providing for The National Energy Policy and Regulatory Framework for The Philippine Liquefied Petroleum Gas Industry

The proposed LPG Act seeks to strengthen and streamline the laws and regulations overseeing the domestic LPG industry. The bill aims at instituting reforms in the LPG industry, addressing concerns in health, safety, security, environmental, and quality standards for the benefit of consumers as well as LPG industry players.

This proposed measure shall apply to the importation, refining, refilling, transportation, conveyance, distribution, marketing of LPG, and manufacturing, requalifying, exchanging, and swapping of LPG pressure vessels, and covers all LPG industry players from the bulk suppliers, refillers, brand owners and marketers to the dealers and retailers.

The proposed measure will require LPG players to secure a license to operate from the DOE for a specific activity prior to their commencement of commercial operation. Such license will be valid for three (3) years. The DOE is tasked to regulate, supervise, and monitor the LPG industry participants, and to implement and ensure compliance with the quality and safety standards prescribed in the PNS.

The bill also enumerates the corresponding administrative and criminal penalties for specific violations such as hoarding, underfilling, illegal refilling and engaging in an activity without a valid license to operate, among others. Fines range from P5,000.00 to P1 Million, depending on the offense, aside from suspension of the license to operate, permanent disqualification from engaging in any activity as an LPG industry participant, impounding of LPG products and even imprisonment, depending on the nature of the violation. S. No. 2220 An Act Enhancing the Powers and Functions of the Joint Congressional Energy Commission, Further Amending for the Purpose Section 62 Of Republic Act No. 9136, Otherwise Known as The Electric Power Industry Reform Act of 2001, As Amended

The bill seeks to amends the Electric Power Industry Reform Act of 2001 (EPIRA) by changing the expiration period of the Joint Congressional Energy Commission (JCEC), an oversight body in charge of implementing energy-sector laws.

The bill also seeks to include an additional provision amending the JCEC's oversight role to cover all existing energy laws, including but not limited to the Oil Exploration and Development Act of 1972 (PD 87), and the Downstream Oil Industry Deregulation Act of 1998 (RA 8479), except the Biofuels Act of 2006 (RA 9367).

HEALTH

R.A. No. 11525 An Act Establishing the Coronavirus Disease 2019 (COVID-19) Vaccination Program Expediting the Vaccine Procurement and Administration Process, Providing Funds Therefor, And for Other Purposes (S. No. 2057/H. No. 8648) [February 26, 2021]

This law provides for a procurement process for the vaccine. It outlines the manner of involvement of the DOH and the National Task Force Against COVID-19 (NTF), the national government agencies, and local government units (LGUs), as well as private entities and the role of the Philippine National Red Cross in the procurement of COVID-19 vaccines. It also provides for an indemnity fund and a vaccine card for those who have been inoculated. This measure also cites related laws that shall affect the vaccination program.

This law authorizes the DOH and the NTF to be in the forefront of the program. On account of the pandemic, the DOH and the NTF, either through themselves or jointly in cooperation with any national government agency or their and instrumentality or LGU, are authorized to acquire the vaccine and ancillary supplies and services for their storage, transport, deployment, and administration, pursuant to Negotiated Procurement Under Emergency Cases, Section 53 (b) of RA 9184 (Government Procurement Policy Board) and Section 53.2 of the 2016 Revised Implementing Rules and Regulations of RA 9184.

This measure also provides guidelines for the procurement of COVID-19 vaccines of the Philippine National Red Cross and private entities. In the procurement of vaccine, Red Cross shall prioritize its deployment in accordance with the set priority list and the rule that for every one vaccine bought, one vaccine shall be donated to the vulnerable and indigent. As for private entities, the latter shall make the procurement only in cooperation with the DOH and the NTF through a multiparty agreement which shall include the DOH and the supplier of the vaccine. Any vaccine procurement by these private entities shall be for the exclusive use of their companies and they shall formulate their own recipient list, and implement their operational procedures in accordance with national policies and procedures of DOH.

The law states that LGUs shall procure no more than 75% of their target population for vaccination. Depending on sufficiency of supply, this provision may be adjusted by the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-EID).

The following groups shall be prioritized for vaccination:

healthcare workers,
 senior citizens,

3) persons with co-morbidities,4) frontline personnel in essential services including uniformed personnel and teachers, and

5) indigent population.

This measure requires that the national government, LGUs, private entities and Philippine Red Cross, can only procure vaccines that have a Certificate of Product Registration and an Emergency Use Authorization (EUA) and registered with the Philippine Food and Drug Administration (PFDA).

For transparency, it is required that within 30 days after award or execution of definitive agreement or after the effectivity of this law, the following information shall be posted in a conspicuous place of the procuring agency and in the online portal of the Government Procurement Policy Board (GPPB):

1. approved budget for the contract,

2. name and details of the COVID-19 vaccine or ancillary service or supplies,

3. name of the supplier, manufacturer, or distributor, and

4. amount of contract as awarded. Moreover, the law tasks the Health Technology Assessment Council (HTAC) to issue recommendations to DOH and Philhealth on the Covid-19 vaccine based on preliminary data of Phase III clinical trials and the World Health Organization (WHO) recommendations.

The law grants an immunity from suit and liability to authorized persons involved in the vaccination program in relation to claims arising from the administration or use of the vaccine, except those that come from willful misconduct and gross negligence. PhilHealth shall administer a National Vaccine Indemnity Fund as a trust fund to compensate any person inoculated through the COVID-19 Vaccination Program, in case of death, permanent disability or hospital confinement. The law authorizes P500 Million to augment the funds of PhilHealth for this purpose which will be sourced from the Contingent Fund under RA No. 11518 (General Appropriations Act of 2021).

A COVID-19 vaccine card shall be issued to Filipinos who have received the vaccine. It shall be a record of the inoculation of an individual and shall contain his/her personal information; brand name and manufacturer of the vaccine; date of inoculation; name of hospital or health facility where the vaccine was received; name and license number of health worker who administered the vaccine, among other information. Falsification of a vaccine card shall be sanctioned under the Revised Penal Code.

The Vaccine Czar, the DOH and the IATF-EID shall submit a monthly report to Congressional Oversight Committee on the implementation of Covid-19 Vaccination Program.

JUDICIAL REFORMS

S. No. 1886 An Act Further Expanding the Jurisdiction of the Metropolitan Trial Courts, Municipal Trial Courts in Cities, Municipal Trial Courts, And Municipal Circuit Trial Courts, Amending for The Purpose Batas Pambansa Blg. 129, Otherwise Known as The 'Judiciary Reorganization Act of 1980,'As Amended

The bill seeks to expand the jurisdiction of the Metropolitan Trial Courts, Municipal Trial Courts in cities, Municipal Trial Courts, and Municipal Circuit Trial Courts by amending Batas Pambansa Blg. 129 or the Judiciary Reorganization Act of 1980, as amended.

- 1. The amendments in Section 19 provides that the Regional Trial Courts shall exercise exclusive original jurisdiction:
 - In all civil actions which involve the title to, or possession of, real property, or any interest therein, where the assessed value exceeds P400,000.00 except for forcible entry into, and unlawful detainer of lands or buildings, original jurisdiction over which is conferred upon the Metropolitan Trial Courts, and Municipal Trial Courts in Cities, Municipal Trial Courts, and Municipal Circuit Trial Courts;
 - 2) In all actions in admiralty and maritime jurisdiction where the demand or claims exceeds P2 Million;
 - 3) In all matters of probate, both testate and intestate, where the gross value of the estate exceeds P2 Million;
 - 4) In all other cases in which the demand, exclusive of interest, damages of whatever kind, attorney's fees, litigation expenses and costs or the value of the property in controversy exceeds P2 Million.
- 2. The amendments in Section 33 provide that the Metropolitan Trial Courts, Municipal Trial Courts in Cities, Municipal Trial Courts, and Municipal Circuit Trial Courts shall exercise:
 - 1) Exclusive original jurisdiction over civil actions and probate proceedings, testate and

intestate, including the grant of provisional remedies in proper cases, where the value of the personal property, estate, or amount of the demand does not exceed P2 Million), exclusive of interest, damages of whatever kind, attorney's fees, litigation expenses, and costs, the amount of which must be specifically alleged;

- 2) Exclusive original jurisdiction in all civil actions which involve title to, or possession of, real property, or any interest therein where the assessed value of the property or any interest therein does not exceed P400,00.00, exclusive of interest, damages of whatever kind, attorney's fees, litigation expenses and costs;
- 3) Exclusive original jurisdiction in admiralty and maritime actions where the demand or claim does not exceed P2 Million.

S. No. 1931 An Act Improving Confirmation of Imperfect Titles, Amending for The Purpose Presidential Decree No. 1529, Commonwealth Act No. 141, And Republic Act No. 9176, and for Other Purposes

The bill introduces the following amendments:

1) In Sec. 14 of P.D. No. 1529, the following persons may file in the proper Regional Trial Court an application for registration of title to land not exceeding twelve (12) hectares whether personally or their authorized representatives:

- Those who have been in open, continuous, exclusive and notorious possession and occupation of alienable and disposable lands of the public domain under a bona fide claim of ownership for at least thirty (30) years immediately preceding the filing of the application for confirmation of title except when prevented by war or force majeure;
- 2) Those who have acquired ownership of private lands or abandoned riverbeds by right of accession or accretion under the existing laws; and
- 3) Those who have acquired ownership of land in any other manner provided for by law.
- 2) In Sec. 48, Chapter VII of Commonwealth Act No. 141, it provides that the following citizens of the Philippines, occupying lands of the public domain, but whose titles have not been perfected may apply to the Regional Trial Court where the land is located, for confirmation of their claims and the issuance of a certificate of title to wit:
 - a) Those who have been in open, continuous, exclusive and notorious possession and occupation of alienable and disposable lands of the public domain under a bona fide claim of ownership for at least thirty (30) years immediately preceding the filing of the application for confirmation of title except when prevented by war or force majeure;
 - b) Those who have acquired ownership of private lands or abandoned riverbeds by right of accession or accretion under the existing law; and

- c) Those who have acquired ownership of land in any other manner provided for by law.
- 3) The proposed measure inserts a new Sec. 45 which provides that all applications shall be filed with the Community Environment and Natural Resources Office (CENRO). The CENRO is mandated to process the application within 120 days to include compliance with the required legal requirements.

The CENRO shall forward their recommendation to the Provincial Environment and Natural Resources Office (PENRO), if the area of the land is below five (5) hectares; to the DENR Regional Director if the area of the land is five (5) to ten (10) hectares; and to the Secretary of DENR if the area of the land is more than ten (10) to twelve (12) hectares, who shall have five (5) days to approve or disapprove the patent.

4) In Section 7, it provides that in addition to the penalties provided in the Revised Penal Code and in R. A. No. 8560, as amended, a geodetic engineer who shall prepare willfully or through gross inexcusable negligence a sworn certification that contains false, fraudulent, or incomplete data or information, shall be penalized with a fine of not less than P100,000.00 but not more than P500,000.00, or imprisonment of not less than six (6) months but not exceeding six (6) years, or both, at the discretion of the Court.

S. No. 1354 An Act Amending Articles 183 and 184 of Act No. 3815, As Amended, Otherwise Known as the Revised Penal Code

The bill amends Article 183 of the Revised Penal Code by increasing the imposable penalty from *arresto mayor* in its

maximum period to *prision correccional* in its minimum period, to *prision mayor* in its minimum period to *prision mayor* in its medium period, upon any person who, knowingly makes untruthful statements and not being included in the provisions of the next preceding articles, shall testify under oath, or make an affidavit, upon any material matter before a competent person authorized to administer an oath in cases in which the law requires.

The bill provides that the penalty shall be imposed in its maximum period if the person responsible for the commission of such felony is a public officer or employee. The bill provides that the offender shall also suffer a fine not to exceed P1 Million and perpetual absolute disqualification from holding any appointive or elective position in the government or in any agency, entity or instrumentality thereof.

LOCAL/REGIONAL GOVERNMENT

R.A. No. 11535 An Act Making the Position of a Cooperatives Development Officer Mandatory in the Municipal, City and Provincial Levels, Amending for The Purpose Republic Act No. 7160, Otherwise Known as The "Local Government Code of 1991", As Amended (S. No. 1855/H. No. 5925) [April 9, 2021]

The law makes the position of Cooperative Development Officer (CDO) mandatory in the municipal, city and provincial levels. The CDO shall take charge of the office for the development of cooperatives registered with the Cooperative Development Authority. He/she shall formulate measures and develop plans for the integration of cooperatives values and practices in programs and projects which the governor or mayor is empowered to implement.

PUBLIC ORDER AND NATIONAL RECONCILIATION

S. No. 1055 An Act Establishing a Separate Facility for Prisoners Convicted of Heinous Crimes

The bill proposes the construction of the Maximum Penal Institution in a suitable location as determined by the Secretary of the DOJ preferably within a military establishment or in an island separate in the mainland.

The proposal mandates that there shall be three Maximum Penal Institutions for heinous crimes in Luzon, Visayas, and Mindanao.

The transfer of inmates to the facility shall be headed by the Bureau of Corrections (BuCor). The bureau may seek the assistance of the Philippine National Police (PNP) through the Department of Interior and Local Government (DILG) when the means of transporting will be done through the use of an aircraft vessel. Such transfer shall be made within 30 days from the completion of the construction of the Heinous Crimes Facility.

S. No. 1155 An Act Fixing the Validity Period of License to Own and Possess, Permit to Carry Outside of Residence or Place of Business and Registration of Firearms, Amending for The Purpose Sections 7 And 19 Of Republic Act No. 10591, Otherwise Known as The 'Comprehensive Firearms and Ammunition Regulation Act'

This bill authorizes persons, whose lives are in imminent danger, to carry firearms outside of their residences. The following are qualified to apply for permit to carry firearms:

1. Members of the Philippine Bar;

2. Certified Public Accountants;

3. Accredited Media Practitioners;

4. Cashiers, Bank Tellers;

5. Priests, Ministers, Rabbi, Imams;

6. Physicians and Nurses;

7. Engineers; and

8. Businessmen, who by the nature of their business or undertaking, are exposed to high risk of being targets of criminal elements.

A permit to carry firearms shall be provided by the Chief Philippine National Police (PNP) to the abovementioned professions. It shall be the burden of the applicant to prove that his/her life is under actual threat by submitting a threat assessment certificate from the PNP.

All types of licenses to possess a firearm shall be renewed every five (5) years reckoned from the birthdate of the licensee, unless sooner revoked or suspended. The registration of firearm shall be renewed every five (5) years reckoned from the birthdate of the licensee. The application for the renewal of the license or registration may be submitted to the Firearms and Explosives Office (FEO) of the PNP, within six (6) months before the date of the expiration of such license or registration.

Failure to renew the license and registration on or before the date of expiration of the firearm shall cause the revocation of the license or registration of the firearm/s under said license. The firearm shall be confiscated in favor of the government after due process. Failure to renew the license or registration twice as prescribed shall cause the holder of the firearm to be perpetually disqualified from applying for any firearm license.

S. No. 1233 An Act Expanding the Use of the Legal Assistance Fund, Amending for The Purpose Section 26 Of Republic Act No. 8042, As Amended, Otherwise Known as The Migrant Workers and Overseas Filipinos Act of 1995 The bill amends R.A. No. 8042 by expanding the use of the Legal Assistance Fund to include fees for the foreign lawyers to be hired by the head of mission of the Philippine embassy concerned to represent migrant workers and overseas Filipinos facing charges, or in filing cases against abusive employers, and other offenders abroad; in obtaining bail bonds to secure the temporary release of migrant workers and overseas Filipinos in distress; and other kinds of bonds required by the foreign court, agency or tribunal where the case is pending.

The bill mandates that the legal assistance fund shall be immediately available to all migrant workers and overseas Filipinos in distress, from the time of the commencement of the complaint, and in all stages of the proceedings until the promulgation and execution of judgment, and at all levels of appeal.

S. No. 1832 An Act Strengthening and Modernizing the Bureau of Fire Protection, Amending for The Purpose Republic Act No. 6975, Otherwise Known as The Department of the Interior and Local Government Act of 1990, Providing Funds Therefor and for Other Purposes

The bill modernizes the Bureau of Fire Protection (BFP) by for revising its organizational structure and staffing pattern as well as upgrading its officers and other personnel.

The proposed measure grants the acquisition of new equipment for fire protection and the phasing out of old and obsolete ones. It presents the formation of a specialized services department that would handle high rise building fires, forest fires, chemical fires, aircraft and airport fires.

The expansion of BFP's responsibilities shall also extend to the prevention and suppression of fires in economic zones, agroindustrial zones, IT Parks, tourism eco-zones, forests, seaports and vessels docked at piers and wharves, as well as petroleum industry installations.

The bill mandates the establishment of BFP regional offices. It proposes the formation of search and rescue force and hazardous materials (HAZMAT) units as well as emergency medical services (EMS) in first to third class municipalities and cities.

TAX ENHANCEMENT MEASURES

R.A. No. 11534 An Act Reforming the Corporate Income Tax and Incentives System, Amending for The Purpose Sections 20, 22, 25, 27, 28, 29, 34, 40, 57, 109, 116, 204 And 290 of The National Internal Revenue Code of 1997, As Amended, And Creating Therein New Title XIII, And for Other Purposes (S. No. 1357/H. No.4157) [March 26, 2021]

This Act amends 13 sections of the 1997 National Internal Revenue Code and creates a new title, Title XIII, on Fiscal Incentives Review Board.

These amendments aim to attract investments that will generate employment, enhance productivity, stimulate inclusive economic growth and countrywide development while exercising fiscal prudence and maintaining stability.

To attract investments, the law provides for direct decrease of tax rates, by applying deductions on gross income and by granting income tax holidays for corporations.

This law covers corporations, including one-person corporations; partnerships (regardless of how created or organized); joint stock companies; joint accounts; associations or insurance companies, but does not include general professional partnerships, joint ventures or consortium formed for the purpose of undertaking construction projects or engaging in coal, geothermal, and other energy operations based on an operating consortium agreement under a service contract with the government.

This measure also imposes taxes on dividends of nonresident alien individuals; charges corporate income tax on domestic as well as resident foreign corporations, and regional operating headquarters of multinational corporations. The law, however, does not impose corporate income tax on regional or area headquarters.

The tax on non-resident alien individuals shall consist of tax on their dividends on stocks in domestic corporations or joint stock companies, mutual fund or insurance companies, regional operating headquarters or multinational companies as well as their share in the net income of partnership. Moreover, a 10% tax on royalties shall be imposed on their books, literary works and musical compositions. For royalties on cinematographic films, taxes shall be imposed in accordance with the provisions governing royalties derived from sources within the Philippines. However, the non-resident alien's interest income on long term deposit or investment shall not be taxed. Said no-tax interest income shall derive from savings, common or individual trust funds, deposit substitutes, investment management accounts and other investments as evidenced by certificates prescribed by the Bangko Sentral ng Pilipinas (BSP), provided that the holder does not preterminate the investment before the fifth year.

In general, the annual tax rate for income of a domestic corporation stands at 25%, effective July 1, 2020. For those with net taxable income that do not exceed P5 Million and with total assets not exceeding P100 Million, the tax rate is 20% for the taxable year. These assets do not include land on which the firm's office, plant or equipment are situated. However, the Act provides

for a minimum annual corporate income tax of two percent (2%) of gross income. This rate begins on the fourth (4th) taxable year immediately following the year in which such corporation commenced its business operations, when the minimum income tax is greater than the tax computed under subsection A of Section 6 of this law. This measure also provides that from July 1, 2020 to June 30, 2023, the minimum corporate income tax shall be one percent (1%) of gross income.

Dividend earnings of domestic corporation shall not be taxed but dividends coming from abroad should be invested in working capital, capital expenditures, dividend payments, investment in subsidiaries and infrastructure projects for the next taxable year so as to be tax-exempt. To be eligible, domestic corporations should hold at least 20% of the outstanding shares of that foreign corporation and should have held the shareholdings for a minimum of two (2) years at the time of dividend distribution.

For private educational institutions and hospitals, a 10% tax shall be imposed on taxable income. However, from July 1, 2020 to June 30, 2023, the rate shall be one percent (1%) of taxable income.

In general, rate of income tax of foreign corporation stands at twenty-five percent (25%) of taxable income, effective July 1, 2020. However, the law also provides for a minimum income tax for resident foreign corporations which is—effective July 1, 2020 until June 30, 2023—one percent (1%) of gross income as minimum rate.

This Act also provides for transactions that are exempt from value-added tax (VAT). These are sales on (socialized) lowcost lot and low-cost house and lot as defined under Republic Act 7279 or the Urban Development and Housing Act (UDHA) of 1992. This refers to a residential lot which costs P2.5 Million and below, and residential lot and dwelling costing P4.2 Million and below. However, these values may change starting January 1, 2024, and every three (3) years thereafter, these amounts shall be adjusted to their current values using the Consumer Price Index (CPI) as published by the Philippine Statistical Authority (PSA).

Other products that are VAT-free sale or VAT-free importation are the following:

(1) drugs and medicines for diabetes, hypertension, high cholesterol, cancer, mental illness, tuberculosis and kidney diseases, provided that DOH shall issue a list of the approved drugs and medicines within sixty (60) days from the effectivity of this Act;

(2) sale or importation of the following from January 1, 2021-December 31, 2023: (a) capital equipment, its spare parts and raw materials for the production of PPE components such as coveralls, masks, gowns, surgical cap, N-95 masks, scrub suits, goggles and face shield, gloves, surgical gloves, shoes, shoe covers for COVID-19 prevention, (b) all drugs, vaccines and medical devices, prescribed and used for the treatment of COVID-19 (c) drugs for the *treatment of* COVID-19 approved by the FDA for use in clinical trials, including raw materials necessary for the production of said drugs;

(3) sale or lease of goods or properties or performance of services other than the abovementioned transactions, the gross annual sales or receipts do not exceed three million pesos (P 3,000,000.00).

In the new Title XIII, on the other hand, the law imbues the Fiscal Incentive Review Board (FIRB) with expanded powers and functions such as policy making and oversight, grant and administration of tax incentives and sanctions on violations. To efficiently fulfill these functions, the law mandates a new organizational set-up for the Board. This shall be composed of a chairperson, to be held by the Secretary of Finance; a cochairperson who is the Secretary of Trade and Industry, and members to be composed of the Executive Secretary of the Office of the President; the Secretary of the Department of Budget and Management (DBM); and the Director General of the National Economic and Development Authority (NEDA).

The Board shall have a technical unit that shall be composed of the following: (1) Undersecretary of Finance as chairperson, and members to be composed of the following: (1) Undersecretary of the Office of the Executive Secretary, (2) Undersecretary of Trade and Industry and Board of Investments Managing Head or Assistant Secretary of Trade and Industry, (3) Undersecretary or Assistant Secretary of DBM, (4) Deputy or Assistant Director General of NEDA, (5) Commissioner or Deputy Commissioner of Internal Revenue, (6) Commissioner or Deputy Commissioner of Customs, (7) Commissioner of Philippine Competition Commission, and (8) Director General or Chairperson or Administrator of the Investment Promotion Agencies (IPAs), provided that participation of the IPA representative in decision-making and deliberations in the technical committee shall be limited only to matters concerning their particular IPA. This technical unit shall be supported by a secretariat to be headed by an Assistant Secretary of Finance and staffed by the National Tax Research Center (NTRC). The latter shall have their own structure and staffing pattern and shall have an initial separate appropriation to be drawn from the National Treasury. Thereafter, funding shall be under the GAA.

FIRB shall have administration over business enterprises registered under the Investment Promotion Agencies (IPAs) and with approved project or activity under the Strategic Investment Priority Plan. IPAs are incentive granting government agencies like the Board of Investments (BOI), Philippine Economic Zone Authority (PEZA), Bases Conversion and Development Authority (BCDA), Subic Bay Metropolitan Authority (SBMA), Clark Development Corporation (CDC), John Hay Management Corporation (JHMC), Poro Point Management Corporation (PPMC), among others. These agencies shall categorize the activities of businesses or enterprises to which they will grant tax incentives like deductions and income tax holidays. The Strategic Investment Priority Plan shall be formulated by the BOI and may alter the plan depending on criteria for investment priority.

To facilitate the availment of said incentives by registered enterprises, all investment promotion agencies are mandated to set up a one-stop shop action center. These centers shall facilitate the setting up and conduct of registered projects or activities of the enterprises, including coordination with the LGUs and other government agencies. This is also in compliance with RA 11032 or the law on Ease of Doing Business.

For transparency purposes, databases shall be maintained and reports shall be prepared on how the benefits garnered by the enterprises due to tax deductions, tax rates decrease and income tax holidays affected the sector concerned, and the economy as a whole. These shall be in the form of cost-benefit studies on the firm level and shall be published by the FIRB. Annual reports pertaining to these studies shall be submitted to the President and Congress.

The law provides sanctions for violations on reportorial requirements. Registered businesses that fail to comply with these requirements like the non-filing of electronic tax returns at the BIR shall be liable to pay graduated fines based on the number of offenses committed. Fines start at P100,000.00 and ends until the third violation with the cancellation of registration at the IPA concerned or other government agency administering tax incentives.

For a government employee or official who failed to furnish the required tax incentives report or other data and information required, he/she shall be penalized after due process with the withdrawal of his basic salary for a specified number of months in addition to the imposition of administrative penalties

S. No. 2208 An Act Extending the Estate Tax Amnesty and for Other Purposes, Amending Section 6 Of Republic Act No. 11213, Otherwise Known as The 'Tax Amnesty Act'

This bill extends the period of estate tax amnesty from June 15, 2021 to June 14, 2023.

The administrator or executor of the estate, legal heirs, transferees, or beneficiaries who may avail of said amnesty shall file a sworn Estate Tax Amnesty Return with the Revenue District Office of the Bureau of Internal Revenue (BIR). This shall be in a form as may be prescribed in the Implementing Rules and Regulations (IRR) of this measure. Said Revenue District Office shall be the last residence of the decedent, but in case of non-resident decedents, the Estate Tax Amnesty Return shall be filed and the corresponding amnesty tax shall be paid at the Revenue District Office No. 39, or any revenue district office that shall be indicated in the IRR.

If the said estate has properties still in the name of another decedent or donor, the present holder, heirs, executors or administrators, thereof, shall only file one (1) estate tax amnesty return and pay the corresponding estate amnesty tax based on the total net estate at the time of death of the last decedent covering all accrued taxes under the National Internal Revenue Code (NIRC) of 1997, as amended.

The Revenue District Officer shall issue and endorse an acceptance payment form, as prescribed in the IRR for the authorized agent bank or, in the latter's absence, the revenue

collection agent or municipal treasurer concerned to accept the tax amnesty payment. Proof of the settlement of the estate shall be attached to said return in order to verify the mode of transfer and the proper recipients.

S. No. 2232 An Act Taxing Philippine Offshore Gaming Operations, Amending for The Purpose Sections 22, 25, 27, 28, And Adding a New Section 125-A of The National Internal Revenue Code of 1997, As Amended, and for Other Purposes

This bill taxes the Offshore Gaming Licensee (OGL) or the offshore gaming operator, its employees, and its accredited service providers.

An OGL is a gaming operator duly licensed and authorized by the Philippine Amusement and Gaming Corporation (PAGCOR) through a gaming license. A special economic zone authority, a tourism zone authority or a free port authority may also issue such license to the OGL. The latter can conduct gaming operations, including acceptance of bets from offshore clients.

The OGL shall be charged with taxes on gaming-revenue and on non-gaming revenue.

The OGL shall be charged with a gaming tax of five percent (5%) of gaming income. It shall mean either the gross gaming revenue or the agreed predetermined minimum monthly revenue or receipts from gaming, whichever is higher. The gross gaming revenue shall mean gross wagers less pay-outs. The gaming income tax shall be directly remitted to the Bureau of Internal Revenue (BIR) not later than the twentieth (20th) day following the end of each month.

Income tax on non-gaming revenues of Philippine-based OGL shall be 25% of the taxable income derived from each taxable

year from all sources within and without of the Philippines. Income tax of foreign-based OGLs on non-gaming revenues attributed to game offerings or facilities located within the Philippines shall also be taxed at 25% of the taxable income.

Any special zone authority, a tourism zone authority or a free port authority may impose regulatory fees on the OGL which shall not cumulatively exceed two percent (2%) of the gross gaming revenue and similar activities of the OGL or from a predetermined minimum guaranteed fee, whichever is higher.

Alien individuals, who are employed by the OGL, regardless of visa status or employment permit, shall pay a final withholding tax of 25% on their gross income, provided that their withholding tax per month for any taxable month, shall not be less than P12,500.00. Gross income shall mean basic salary/wages, annuities compensation, remuneration, and other emoluments, such as honoraria and allowances received from such service provider or offshore gaming licensee.

An accredited service provider of the OGL shall be regarded as domestic corporation and shall pay the tax imposed in Section 27 (A) of the NIRC of 1997. It shall not be subject to the provisions of Section 125 (A) of the Code. An accredited service corporation provides ancillary services to the OGL. It is a corporation duly created or organized in the Philippines or under its laws and duly authorized by the PAGCOR, any special economic zone authority, a tourism zone authority or a free port authority.

TRADE, COMMERCE AND ENTREPRENEURSHIP

S. No. 1840 An Act Amending Republic Act No. 8762, Otherwise Known as The Retail Trade Liberalization Act

of 2000, By Lowering the Required Paid-Up Capital for Foreign Retail Enterprises, And for Other Purposes

The bill mandates that a foreign retailer shall maintain a minimum paid-up capital of the Philippine peso equivalent of three hundred thousand USD\$ 300,000.00 in his/her retail firm in the Philippines, regardless of whether it is a single proprietorship or a corporation.

In instances when the foreign retailer is engaged in retail trade in more than one physical store in the country, the investment for each store shall be the peso equivalent of USD\$ 150,000.00.

In case the foreign retailer has no physical store in the Philippines, he/she must have a fixed place of business in the Philippines, such as a place of management, a physical office housing their employees/ staff or a warehouse.

Registration of business by a foreign retailer corporation shall be made with the Securities and Exchange Commission (SEC) and for the foreign retailer single proprietor, registration shall be with the Department of Trade and Industry (DTI). For registration with the SEC or DTI, the retailer shall submit proof of inward remittance of its capital investment to its account with a bank in the Philippines, such as the Bangko Sentral ng Pilipinas (BSP) registration document or a certificate of inward remittance of foreign exchange issued by a bank in the form prescribed by BSP.

The Securities and Exchange Commission (SEC) shall be in charge of monitoring foreign retailer corporation's maintenance of the required minimum paid up capital; for the foreign single proprietor, the monitoring authority shall be the Department of Trade and Industry (DTI).

The bill further provides that DTI, SEC, BSP and the National Economic and Development Authority (NEDA) shall

review the minimum paid-up capital every five (5) years. The recommendation of these agencies shall be submitted to Congress.

For failure to comply with the reportorial requirement, a penalty of paying not less than P50,000.00 but not more than P500,000.00, for each violation, and a similar amount of penalty for each day thereafter until the reportorial requirement is fulfilled. Further, violation of any provision in this act shall be punishable by imprisonment of not less than six (6) years and one day but not more than eight (8) years and a fine of not less than P1 Million but not more than P20 Million.

RATIFICATION OF TREATIES AND/OR INTERNATIONAL AGREEMENTS/CONVENTIONS

Res. No. 83 Resolution Concurring in the Ratification of the Treaty on the Prohibition of Nuclear Weapons (PSR-620) [February 1, 2021]

This resolution concurs in the ratification of the Treaty on the Prohibition of Nuclear Weapons. The President of the Philippines ratified the treaty on November 18, 2020 and subsequently submitted the same to the Senate for concurrence, in accordance with the Constitution.

While prohibiting the use of nuclear weapons, the end goal of the treaty is the total elimination of all nuclear weapons. It prohibits State Parties from:

1) developing, testing, producing, manufacturing, transferring, possessing, stockpiling, using or threatening to use nuclear weapons;

2) assisting, encouraging or inducing anyone to engage in said activities; and

3) allowing nuclear weapons to be stationed, installed or deployed in their respective territories. It also commits State Parties to aid individuals affected by the use or testing of nuclear weapons and to take appropriate measures in the environmental remediation of areas contaminated by nuclear munitions.

SUSTAINABLE DEVELOPMENT

R.A. No. 11502 An Act Declaring the Month of October of Every Year as The "National Cooperative Month" (S. No. 1807/H. No. 5422) [December 16, 2020]

The law mandates the chairperson of the Cooperative Development Authority (CDA), in coordination with the cooperative development councils, national and local federations and union of cooperatives, and other agencies of the government to promote the principles and values of cooperatives, and encourage cooperative movement during the month of October.

R.A. No. 11548 An Act Granting the President of the Philippines the Power to Defer the Increases in Contributions of the Social Security System for the Duration of the State of Calamity Under Proclamation No.929, S. 2020, As Amended by Proclamation No. 1021, S. 2020, Amending Section 4(A)(9) Of Republic Act No. 11199, Also Known as The "Social Security. Act of 20183 (S. No. 2027/ H. No. 8512) [May 26, 2021]

The law gives the President of the Philippines the power to defer the implementation of increases in contribution rates of the Social Security System during the proclaimed state calamity due to COVID-19 or Proxlamation No. 929, Series of 2020.

The law provides that the implementation of the increase of one percent (1%) in contribution rates in 2021, and the monthly

salary credits, may be suspended by the President of the Philippines for the duration of the state calamity, upon recommendation of the Social Security Commission, and after consultation with the stakeholders.

The other scheduled contribution rates and the monthly salary credits provided in the law shall continue to be valid and effective.

The law provides further that no changes in the implementing rules or administrative procedures shall be introduced by the Social Security Commission that will defer disbursement of benefits presently being enjoyed by its members.

S. No. 1077 An Act Creating a National Transportation Safety Board, And Appropriating Funds Thereof

The bill seeks to promote safety in the transportation of people and goods through cost-effective measures that may prevent, remedy or mitigate crashes, accidents, and serious incidents involving any mode of transport.

The bill proposes the creation of a National Transport Safety Board (NTSB) consisting of seven (7) full-time members, who shall be appointed by the President. The Board shall be headed by the Chairman with a term of five (5) years but may be renewed for a non-extendible period of one (1) year. The Chairman shall be the Chief Executive Officer of the Board. The members of the Board must represent each of the transportation sectors (land, rail, air, and sea); and at least two (2) of the full-time members must come from the commuting public representing organizations advocating for road safety. The Board shall have an Executive Director who will be appointed by the Chairman.

The overall policy in the creation of the NTSB is to promote safety in the transport of people and goods to prevent,

remedy, or mitigate accidents involving any mode of transport, including those that involve the use of pipelines and conveyors. In this regard, the NTSB is authorized to do any of the following, among others:

I. Conduct independent investigations on:

- 1. Aircraft accidents and serious incidents, except those involving State aircrafts;
- 2. Motor vehicles crashes;
- 3. Railroad incidents and accidents;
- 4. Pipeline incident
- 5. Major maritime transportation and aerial accidents or incidents occurring within Philippine maritime jurisdiction, except those involving domestic and foreign military vessels and ships, occurring within the Philippine National Territory

6. Other incidents which are catastrophic and a recurring character.

The Board shall submit a report to Congress and the President, within sixty (60) days from the completion of the Board's investigation on each incident. However, said report shall not be admitted as evidence or used in any suit or action for damages, except when the criminal aspect of the accident or incident is put into issue.

The members of the Board and its employees shall have immunity from suit arising from the performance of their functions conducted in good faith, without fault and negligence, and without violation of any existing laws, rules and regulations during the pendency of its investigation of a transportation-related accident under its jurisdiction as provided under this Act. A Transportation Safety Fund shall be created from the Board's savings to be deposited in a special trust fund administered by the Board. The Fund shall be used exclusively for the following purposes:

1. Operational expenses in investigating major accidents;

2. Studies and research in the causes and possible prevention of accidents and other disasters;

3. Reimbursement of extraordinary expenditures and expenses of government and private agencies and/or persons mobilized by the Board in investigating major accidents; and

4. Training and related conferences to further and enhance the expertise of the officers and employees of the Board.

For the initial organization and operations of the Board, the sum of P50 Million shall be appropriated from the National Treasury.

S. No. 1582 An Act Establishing a Network of Pop-Up Bicycle Lanes and Emergency Pathways for Use During the Duration of the Covid-19 Pandemic, And for Other Purposes

This bill, or the Safe Pathways Act, proposes to create a network of pop-up bicycle lanes and people-oriented emergency pathways in local government units (LGUs).

The pathways are intended for non-motorized vehicles only, such as bicycles. This is in line with the need for physical distancing and limited mobility, amid the lack of public transport in the time of COVID-19 pandemic. These lanes, while intended for non-motorized vehicles may accommodate electric scooters, electric tricycles, and similar transport modes subject to guidelines to be set by the Department of Transportation (DOTr) and other agencies. These pathways shall directly connect to medical facilities and other private and public places. The bill also mandates the provision of adequate parking spaces for non-motorized vehicles in all public places, government offices, and major commercial establishments. To promote the use of non-motorized transport modes, public and private sectors are also instructed to develop necessary infrastructure facilities and programs for its implementation, such as showers, changing areas and hydration facilities. People involved shall follow physical distancing measures during travel.

This measure also provides that DOTr, DILG, and Department of Public Works and Highways (DPWH), in coordination with relevant agencies, shall prepare to permanently adopt the safe pathways measure, as appropriate. In line with this, the DPWH is instructed to revise its manuals and guidelines for road design and construction to include the aspect of safety for pedestrians and non-motorized vehicle users; and to consider the allocation of road space for non-motorized vehicles on national and local roads.

The LGUs shall coordinate and issue the necessary measures for adoption and implementation of this measure.

YOUR COMMITTEES' ACCOMPLISHMENTS

COMMITTEE MEETINGS AND PUBLIC HEARINGS

In keeping with the Senate mandate of coming up with responsive and relevant laws, the different Senate Committees and oversight committees conducted a total of 335 public hearings/ bicameral conferences/technical working group/consultations (333 by the committees and two by the oversight Committees) for the whole of the Second Regular Session of 18th Congress from July 27, 2020 up to June 28, 2021. The hearings, meetings, conferences and consultations dealt with and looked into issues of national importance.

THE STANDING COMMITTEES

Overall, the standing committees and their subcommittees conducted a total of 333 public hearings/meetings/bicameral conferences/technical working groups/consultations.

Among the most active are the following:

The *Committee on Finance* including its 11 subcommittees which had 58 hearings/meetings/conferences/ consultations;

The *Committee on Basic Education, Arts and Culture* which conducted 29 public hearings/technical working groups/ conference committee undertakings/organizational meetings;

The *Committee on Energy* which conducted 26 public hearings/technical working groups/conference committee undertakings/organizational meetings;

The Committee on Labor, Employment and Human Resources Development and the Committee on Trade, Commerce and Entrepreneurship which both conducted a total of 15 public hearings/technical working group hearings/ organizational meetings each;

The Committee on Agriculture, Food and Agrarian Reform and the Committee on Foreign Relations which each conducted a total of 14 public hearings/technical working group hearings/organizational meetings;

The Committee on Local Government (including its subcommittees); Committee on Public Order and Dangerous Drugs and the Committee on Women, Children, Family Relations and Gender Equality which all conducted 13 public hearings/technical working group meetings each; and

The *Committee on Justice and Human Rights* which had ten public hearings/technical working group meetings.
